INDEPENDENT REMANUFACTURER REGISTRATION SUPPLEMENT

IMPORTANT NOTE: Even if you qualify as an independent remanufacturer under the *Act*, you will not be able to take advantage of any provisions which could benefit you, until you have received confirmation from the CRA that you have been certified as an independent remanufacturer. Until you have received this confirmation, you are required to remit the export charge at the higher rate applicable to other exporters.

You are also required to immediately inform the CRA of any change that affects your status as a certified remanufacturer, and you are required to annually re-apply for such status and confirm to us that you continue to meet the conditions described in Sections 3A, 3B and 3C.

It is a question of fact whether persons not related to each other were at a particular time dealing with each other at arms length.</p>
