This registration supplement is for the sole purpose of allowing exporters operating multiple mills to register with the Canada Revenue Agency (CRA).

In order to obtain an export permit from Foreign Affairs and International Trade Canada (FAITC), an exporter and/or an independent remanufacturer must provide the registration number of the facility where the product was first produced. That registration number is used to determine the region of origin of the products being exported.

This option means that you will maintain books and records by division.</p> <p>(c) You will file one return for each mill.
