- you are a builder and pay or credit the rebate to buyers; or
- the builder paid or credited to you the amount of the rebate.

## Direct deposit information

### What conditions apply?

You can only use this form to request direct deposit of your GST/HST new housing rebate directly in your bank account. If you want information about direct deposit for other types of payments you receive from us, contact us at **1-800-959-5525**. You can also visit our Web site at **[www.cra.gc.ca](http://www.cra.gc.ca)**.

You can only use this form if you are sending a completed Form GST190, "GST/HST New Housing Rebate Application for Houses Purchased from a Builder" or Form GST191, "GST/HST New Housing Rebate Application for Owner-Built Houses", to us. You **cannot** use this form if you receive the rebate directly from a builder, or if you are a builder and you pay or credit the rebate to buyers.

If your financial institution informs us of a change in your financial institution number, branch number, or account number, we may redirect your payment according to that new information. If we are unable to deposit funds in your account, we will mail a cheque to you at the address you give on Form GST190 or GST191.

The account you identify has to hold Canadian funds at a financial institution in Canada.

### **The advantages of direct deposit**

Direct deposit is a safe, convenient, dependable, and time-saving way to receive your GST/HST new housing rebate payment.

Direct deposit payments are less likely to be lost, stolen, or damaged than cheques.

Using direct deposit ensures complete confidentiality.

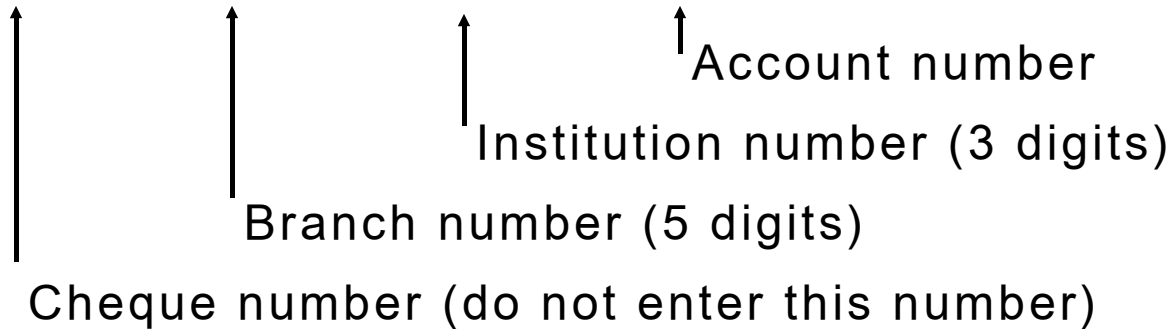
Funds for the direct deposit payment will normally be available in your bank account on the same day that we would have mailed your cheque.
