NOTE: Only filing accounts who reported exports of softwood lumber products subject to the export charge during the period for which a third country adjustment has been declared should file this form.

| Identification | Enter the legal name of the business. For sole proprietorships and partnerships, enter the last and first names of the individuals. For corporations, enter the legal name as stated in the articles of incorporation. |
| 1. Account Number | Enter the registration number provided on your registration confirmation letter. |
| 2. Period covered | The third country adjustment always applies to two (2) consecutive calendar quarters. The four (4) calendar quarters are: January 1 to March 31, April 1 to June 30, July 1 to September 30, and October 1 to December 31. In the From area, enter the first day of the first calendar quarter covered by your refund claim and, in the To area, the last day of the second calendar quarter covered by your claim using the Year/Month/Day (YYYY/MM/DD) format. |
| 3. First calendar quarter | In columns 3.1, 3.2, and 3.3, enter the year and month of the first, second and third consecutive months included in the first calendar quarter covered by your claim, using the Year/Month (YYYY/MM) format. Enter the monthly refund claim to the right of each applicable region. |
| 4. First calendar quarter monthly totals | For the first, second and third month of the first calendar quarter, enter the total of each column's monthly refund claims in boxes 4.1, 4.2, and 4.3, respectively. |
| 5. Second calendar quarter | In columns 5.1, 5.2, and 5.3, enter the year and month of the first, second and third consecutive months included in the second calendar quarter covered by your claim, using the Year/Month (YYYY/MM) format. Enter the monthly refund claim to the right of each applicable region. |
| 6. Second calendar quarter monthly totals | For the first, second and third month of the second calendar quarter, enter the total of each column's monthly refund claims in boxes 6.1, 6.2, and 6.3, respectively. |
| 7. Third country adjustment refund amount | Enter the total of all the amounts entered in boxes 4.1, 4.2, 4.3, 6.1, 6.2, and 6.3. |
