

## ELECTION, OR REVOCATION OF AN ELECTION, NOT TO BE A CANADIAN-CONTROLLED PRIVATE CORPORATION (2006 and later tax years)

- Use this form to:
  - elect under subsection 89(11), to be deemed for the purposes described in paragraph (d) of the definition of Canadian-controlled private corporation (CCPC) in subsection 125(7), not to be a CCPC at any time in or after a tax year; or
  - revoke under subsection 89(12), as of the end of a tax year, an election previously made under subsection 89(11).
- File one completed copy of this election:
  - on or before the filing due date of the *T2 Corporation Income Tax Return* for the particular tax year;
  - at the tax centre where the corporation files its return; and
  - separate from any tax returns. You can put the election in the same envelope with a return, but do not insert it in or attach it to the return.
- We will not accept an election or revocation of an election after the filing due date.
- If you have already revoked an election under subsection 89(12), you have to get written consent from us, and comply with the conditions imposed by us, for another election under 89(11), or another revocation of an election under 89(12).
- Subsections and paragraphs referred to in this form are from the *Income Tax Act*.
