Line 2 of Form TD1SK – Age amount

If you will be 65 or older on December 31, 2012, and your estimated net income from all sources will be between \$33,884 and \$64,231, calculate your partial claim as follows:

Line 1 minus line 6 Enter this amount on line 2 of Form TD1SK.	=		7

Line 7 of Form TD1SK – Spouse or common-law partner amount

If your spouse's or common-law partner's estimated net income for the year (including the income earned before and during the marriage or common-law relationship) will be between \$1,495 and \$16,437, calculate your partial claim as follows:

Base amount	16,437	00	1
Your spouse's or common-law partner's estimated net income for the year	–		2
Line 1 minus line 2 Enter this amount on line 7 of Form TD1SK.	=		3

Line 8 of Form TD1SK – Amount for an eligible dependant

If your dependant's estimated net income for the year will be between \$1,495 and \$16,437, calculate your partial claim as follows:

Base amount	16,437	00	1
Your dependant's estimated net income for the year	–		2
Line 1 minus line 2 Enter this amount on line 8 of Form TD1SK.	=		3

Line 10 of Form TD1SK – Caregiver amount

If your dependant's estimated net income for the year will be between \$15,034 and \$23,837, calculate your partial claim as follows:

Base amount	23,837	00	1
Your dependant's estimated net income for the year	–		2
Line 1 minus line 2 (maximum \$8,803)	=		3
Enter the amount you claimed for this dependant on line 8 of Form TD1SK.	–		4
Line 3 minus line 4 Enter this amount on line 10 of Form TD1SK.	=		5

Line 11 of Form TD1SK – Amount for infirm dependants age 18 or older

You cannot claim this amount for a dependant for whom you claimed the caregiver amount on line 10 of Form TD1SK.

If your dependant's estimated net income for the year will be between \$6,246 and \$15,049, calculate your partial claim as follows:

Base amount	15,049	00	1
Your infirm dependant's estimated net income for the year	–		2
Line 1 minus line 2 (maximum \$8,803)	=		3
Enter the amount you claimed on line 8 of Form TD1SK for this dependant.	–		4
Line 3 minus line 4 Enter this amount on line 11 of Form TD1SK.	=		5
